Scaffolding the Brain: A
Neurobiological Approach to
Assessment and Intervention

Based upon an integration of attachment, affect regulation, and developmental theories, **Integrative Regulation Therapy (iRT: 2009, 2013, 2017, 2020)** is a neurobiological evidence informed brain-based scaffolding developed by Dr. Newton for clinical assessment and intervention. It is designed to focus on emotional security in children, adults, couples, and families of all ages. Training includes learning how to recognize and work with 1) unhealthy entrainment patterns, 2) the unique languages of the cerebral hemispheres, 3) autonomic nervous system arousal ranges, and 4) clinical instinct, voice prosody, affect, and gesture for a whole-body/mind clinical change.

All training includes interactive teaching using didactic, video review, experiential practice, role plays, case presentations, reflective practice, and group discussion.

Eligibility: Licensed or supervised for licensing mental health clinicians (LPCC, LMFT, LCSW, Ph.D., Psy.D.).

She was a post-doctoral fellow in the Department of Psychiatry at UCSD. Dr. Newton trains and supervises master's and doctoral level interns in attachment and affect regulation theories and interventions and has been a member of the Allan Schore Los Angeles Study Group for Affective Neurobiology since 2004. She is the author of *The Attachment Connection* designed to help parents raise secure, emotionally regulated children and the developer of *Integrative Regulation Therapy*, a brain-based focus on biological entrainment. Dr. Newton is the founder and director of the Newton Center for Affect Regulation (NCAR), and she is endorsed by the California Center for Infant-Family and Early Childhood Mental Health as an Infant-Family and Early Childhood Mental Health Specialist and Reflective Practice Facilitator III/Mentor.
